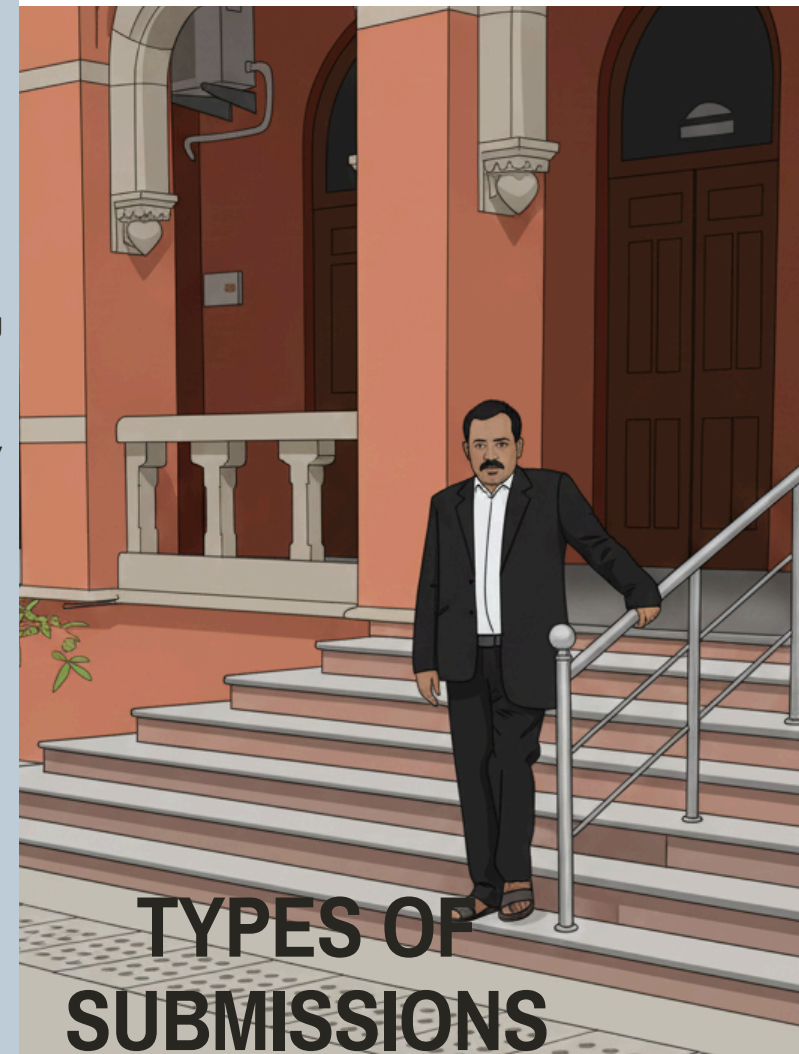

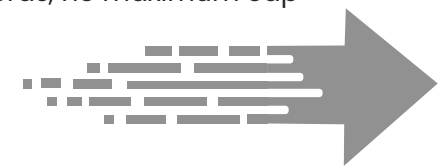

- **Book Reviews** - 1000 to 1500 words
- **Legal Blogs / Opinion Essays** - Minimum 1000 words, no maximum cap
